Charting a Diverse Path in the Legal Profession

Along with taking us down his own career path, David Kelly will discuss current topics in sports law and elaborate on issues related to the entitlement and construction of the Chase Center and the related development.

Speaker Biography

<u>David Kelly</u> is in his eighth season with the Golden State Warriors. His new title Chief Legal Officer Business and Basketball serves as the team's chief legal officer and manages many of the company's key projects and initiatives on both the business and basketball sides of the operation, including legal matters related to the proposed new sports and entertainment center in San Francisco's Mission Bay neighborhood.

Prior to joining the Warriors, David was a partner at Katten Muchin Rosenman LLP where he provided legal counsel to a variety of sports teams and related clients, including the Golden State Warriors, Boston Celtics, Chicago Bulls, Oakland Athletics, Chicago White Sox, St. Louis Blues, Stockton Thunder, Time Warner Cable and Comcast Spectacor, regarding television, radio and internet rights agreements, arena/stadium matters, intellectual property issues, and sponsorship and naming rights agreements. David also advised clients in corporate transactions such as mergers, acquisitions and tender offers; represented underwriters in public offerings; and provided counsel to public companies with respect to securities law compliance, disclosure requirements and corporate governance matters.

Outside of his work with the Warriors, Kelly serves on the board of directors for the Justice and Diversity Center and California ChangeLawyers. He is also a UNCF Leadership Council Member and is involved in numerous bar associations across the country. Most recently, Kelly was named the 2018 Corporate Counsel of the Year in the Private Category by the San Francisco Business Times and Silicon Valley Business Journal.

With Kelly's help, the Warriors were nominated again this year for Sports Team of the Year by the SportsBusiness Journal, an award the team has been nominated for in four of the past five seasons and won in 2014 and 2016. Kelly also represented the franchise in Monaco on February 27, 2018, at the 2018 Laureus World Sports Awards, where the Warriors were honored as a finalist for the Team of the Year award

David has a passion for music and his work as a musician has been featured on the CBS Evening News and CNN, and in Time Magazine, the New York Times, the Chicago Tribune and the Wall Street Journal. He has also toured in the United States, Canada, England, the Netherlands, Sweden, Portugal and Brazil.

A native of Chicago, David earned his Bachelor of Arts degree from Morehouse College in 1996 and his Juris Doctor degree from the University of Illinois College of Law in 2004. He and his wife, Zeenat, have three children.
