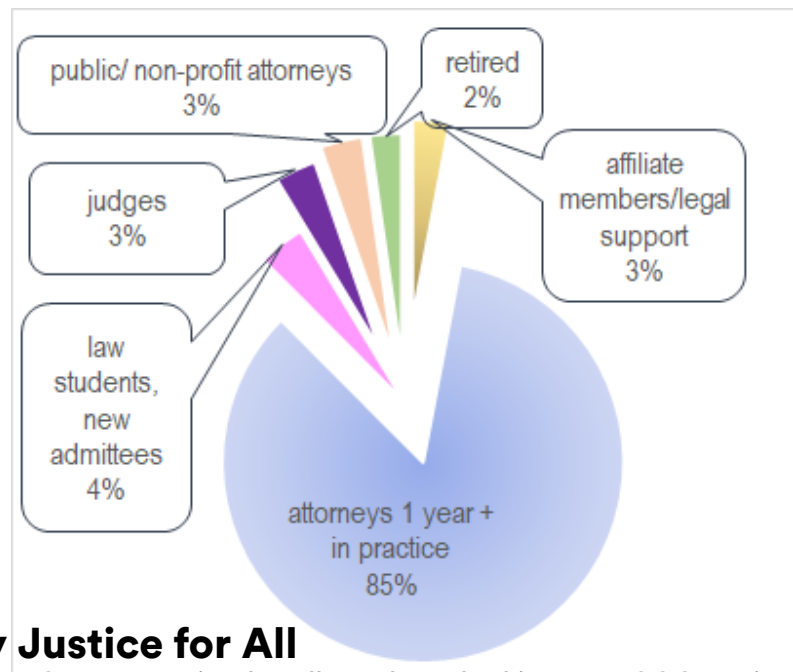

### PAYMENT TERMS

- All payments are non-refundable unless otherwise stated in this Agreement.

### CANCELLATION POLICY

- By Sponsor: Cancellations must be submitted in writing. Refunds will be considered only if cancellation occurs at least 45 days prior to the event.

## Contract / Copy Conditions

The CCCBA shall have the right to cease publishing any advertisement purchased hereunder in the event that Advertiser fails to pay any invoice within 30 days of the date of the invoice.

**CONTRACT YEAR** | Advertising must be inserted within one year of the first insertion to earn the frequency discounts.

**CANCELLATIONS** | If an ad is cancelled by the Advertiser for any reason prior to fulfillment of the contract, Advertiser will be charged back for all costs incurred, including layout. In the event of cancellation, the charge for ad space will be calculated at the higher insertion rate for each advertisement actually published.

**ADVERTISING RESPONSIBILITY** | Staff of the CCCBA must be notified in writing within 10 days of receipt of publication of any errors in advertising or printing flaws.
