Recent court cases now limit the protections available for inherited IRAs and Congress has shifted attention from estate taxation to accelerating taxes on retirement accounts. Many beneficiaries are unable or unprepared to handle the significant wealth represented by inherited IRAs. IRA conduit/accumulation trusts may be the last line of defense against creditor claims, higher taxes, and waste by beneficiaries. We will examine inherited IRA rules and legislation currently being considered by Congress (e.g. "SECURE Act"). Then, IRA conduit/accumulation trust strategies will be applied to common situations in which they should be used. Finally, drafting tips, tricks, and traps will be reviewed.
