# **Old Business:**

- 5. Covid19 response discussion Oliver talked about the finance subcommittees Doomsday (if we make less money than anticipated) and Rainbow & Sunshine (doing better than we expect) Nicole proposed increasing the budgeted amount for Strategic Planning from \$500 to \$1200 to cover the cost of an outside facilitator. A motion was made to increase the strategic planning budget to \$1,200, it was seconded and passed, 16 in favor and one abstention. Theresa and Nicole will work with the facilitator to determine timing of the meeting.

- 8. Resolution Supporting Black Lives Matter Protest A motion was made to make the

We march with the Black Lives Matter movement and all others who condemn racism in all its ugly forms. The motion was seconded and passed, 16 in favor and one abstention.
