# Contra Costa County Bar Association Lawyer Referral & Information Service 24/7 ONLINE SELF-REFERRAL Program

Since you are a Lawyer Referral & Information Service panelist, in addition to receiving referrals through our regular procedures, you have the option of also participating in the 24/7 ONLINE SELF-REFERRAL Program.

Our 24/7 Online Self-Referral Program allows potential clients to choose online the field of law in which they need help, complete the form and pay the LRIS administrative fee. As always, this fee is waived for Plaintiff's personal injury, employee Workers' Compensation and Social Security Disability issues.

The referrals are made on a rotating basis and are tracked in the same manner as all LRIS Referrals. The LRIS 15% percentage fee applies to these referrals as well.

The client immediately receives the contact information for a participating LRIS attorney, and the assigned attorney is notified by email. Clients are instructed to contact the attorney's office within the next 5 days to schedule their 30-minute consultation. The attorney must respond to the client within 5 days of contact.

Below is a list of the LRIS panels that are currently available to the public for online self-referral. Once you are enrolled, you may adjust the panels you signed-up for by logging into your membership profile. <a href="https://cccba.intouchondemand.com">https://cccba.intouchondemand.com</a>
